

THE VILLAGE OF NORTH LEWISBURG, OHIO

ORDINANCE NO. 288

AN ORDINANCE AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO ENTER INTO CONTRACT WITH Community Leasing Partners, for the PURCHASE OF ONE (1) POLICE VEHICLE, AND DECLARING AN EMERGENCY.

WHEREAS, the Village of North Lewisburg has an immediate need for a new police vehicle, and

WHEREAS, the funds for these vehicles have been approved, allocated and are available in the 2024 budget that was passed by Council.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of North Lewisburg, State of Ohio:

SECTION 1. That Council hereby authorizes the Mayor, or his designee, to enter into Leasing contract with Community Leasing Partners, 215 S. Seth Child Road Manhattan, KS 66502, a Division of Community First National Bank, for the lease of:

- A. One (1) 2023 Dodge Durango Sport Utility Vehicle from Jim Shorkey Chrysler Dodge Jeep, 13230 US-30, North Huntingdon, PA 15642 in the amount of Forty Three Thousand and Ninety Six Dollars and Twenty Cents (\$43,096.20). AND
- B. Any and all emergency equipment used to outfit the vehicle described in Section 1. (A) of this ordinance, to be Purchased from Parr Public Safety, 6106 Bausch Rd Galloway, OH 43119, in the amount of Nineteen Thousand Seventy Seven Dollars and Seventeen Cents (\$19,077.17)

SECTION 2. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meetings open to the public in compliance with the law.

SECTION 3. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, convenience and welfare of the Village of North Lewisburg and the inhabitants thereof, to be able to take delivery of this vehicle as soon as possible, and provided it receives the necessary votes required by the ~~City~~ ^{Village} Council, shall be in full force and effect from and after its passage and approval; otherwise to be in full force and effect from and after the earliest period allowed by law. In consideration of such emergency the Village may enter into and proceed with the above described contract without the competitive bidding requirements of O.R.C. 731.14.
